
INFORMATION FOR DATA PROCESSING

This page describes how the site is managed with reference to the processing of the personal data of users who consult it, as well as the methods and purposes of processing personal data.

Personal data will be processed in accordance with the legislative provisions of the aforementioned legislation and the confidentiality obligations set forth therein.

TYPES OF DATA

Browsing data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's computer environment. These data are used only to obtain anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in the event of hypothetical computer crimes against the site.

Your data will be processed only by personnel expressly authorized by the Data Controller.

PURPOSE OF THE TREATMENT

The data will be processed for the following purposes:

1. give the possibility to access the public sections of the site;
2. process requests for information;
3. carry out the obligations established by laws or regulations;
4. the protection of the Data Controller in court

LEGAL BASIS FOR DATA PROCESSING

The legal basis for the processing of personal data for purposes 1-2 is art. 6.1. letter a) of the GDPR, as the processing is necessary to respond to the requests of the interested party. The provision of data for these purposes is optional, but failure to provide it would make it impossible to obtain the requested feedback.

The purpose referred to in number 3 represents the processing of personal data carried out pursuant to art. 6.1. lett. c) of the GDPR, for compliance with a legal obligation. Once the data has been provided, the processing is necessary to fulfill a legal obligation to which the Data Controller is subject. The processing for the purposes referred to in number 4 would be carried out pursuant to art. 6.1. letter f) of the GDPR.

SUBJECTS TO WHOM PERSONAL DATA MAY BE COMMUNICATED

The personal data relating to the processing in question may also be communicated to subjects who are granted the right to access your personal data by law or secondary and / or community regulations. Your data may only be disclosed to competent and duly appointed subjects for the performance of the services necessary for the proper management of the relationship, with a guarantee of protection of the rights of the interested party. Furthermore, some data may be communicated and disseminated to the internet operators of which NKE AUTOMATION S.r.l. uses for the management of its domains.

Your personal data will not be disclosed in any way.

Your data will not be transferred to third countries.

DATA CONSERVATION PERIOD

Personal Data processed for purposes 1-2 will be kept for the time strictly necessary to achieve those same purposes in compliance with the principles of minimization and limitation of conservation pursuant to art. 5.1. lett. e) of the GDPR. In any case, the Data Controller will process the data for the time necessary for contractual and legal obligations. RIGHTS OF THE INTERESTED PARTIES

1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet recorded, and their communication in an intelligible form.
2. The interested party has the right to obtain the indication:
 - a. the origin of the personal data;
 - b. of the purposes and methods of the processing;
 - c. of the logic applied in case of treatment carried out with the aid of electronic instruments;
 - d. the identity of the owner, manager and the representative appointed under article 5, paragraph 2;
 - e. the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the State, managers or agents.
3. The interested party has the right to obtain:
 - a. updating, rectification or, when interested, integration of data;
 - b. the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which the data were collected or subsequently processed;

c. the attestation that the operations referred to in letters a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment proves impossible or involves the use of means

d. manifestly disproportionate to the protected right;

e. data portability.

4. The interested party has the right to object, in whole or in part:

a. for legitimate reasons to the processing of personal data concerning him, even if pertinent to the purpose of the collection

Furthermore, if you believe that the processing of your data is contrary to the legislation in force, you can lodge a complaint with the supervisory authority for the protection of personal data pursuant to art. 77 of the 2016/679 Regulation.

DATA CONTROLLER

The data controller is NKE AUTOMATION S.r.l. based in Alpignano (TO) - S.S. 24 KM 16.2 - in the person of its pro tempore legal representative.

The user has the right to obtain from the owner the cancellation (right to be forgotten), the limitation, the updating, the rectification, the portability, the opposition to the processing of personal data concerning you, and in general can exercise all the rights provided for by art. 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

INFORMATION ON COOKIES
